### **Privacy Policy**

**At REALTORTOOLS® (RT), we understand the importance of protecting your personal information. This policy describes how we collect, use, and safeguard your data on websites owned or controlled by REALTORTOOLS, including REALTORTOOLS.ORG, which has its own privacy policies and terms of use. ## **6. User Rights**

**Users have the following rights regarding their personal information:**

- **Access:** Request access to your personal data.
- **Correction or Deletion:** Request corrections or deletion of your data.
- **Objection:** Object to data processing.
- **Withdrawal of Consent:** Withdraw consent for data processing at any time.
